	nylon rods	NR	N/A	Sanitize every 2 weeks or as needed	If applicable, watch for sharp edges due to gnawing
	Paper Bags	PAP	N/A	Items are unable to be cleaned/sanitized. Once placed in cage item may be transferred into clean caging. Dispose of when soiled	Use size appropriate for cage/animal. No handles. Autoclave except for NHP, Cat, Swine
	PVC tube	PVCT	Inside, N/A, Outside	Sanitize every 2 weeks or as needed	Use appropriate size. Cannot be autoclaved. If applicable, watch for sharp edges due to gnawing
	Rat Retreat	RR	N/A	Sanitize every 2 weeks or as needed	
	Treats	See individual logs	Inside, N/A, Outside	If not consumed within 24hrs remove and discard	Treats may be used for positive reinforcement training, to increase the novelty of an enrichment item, to increase foraging opportunities. Treats may be frozen. Lab approval required
